- e. A statement by you under penalty of perjury that the information in your notice is accurate and that you are the copyright or intellectual property owner or are authorized to act on the owner's behalf;
- f. Your electronic or physical signature.

RAA may request additional information before removing any allegedly infringing material. In the event RAA removes the allegedly infringing materials, RAA will immediately notify the person responsible for posting such materials that RAA removed or disabled access to the materials. RAA may also provide the responsible person with your e-mail address so that the person may respond to your allegations.

RAA reserves the right to terminate, limit or suspend any user's access to the Site in the event of repeated infringing activity. If you believe that a user of this website is a repeat infringer, please follow the above instructions to contact RAA's Copyright Agent. Please include sufficient information to assist RAA in determining that the user repeatedly engaged in infringing activity.
