## Qualifications for Nomination:

### **President- Elect:**

The President-Elect must have been a REALTOR® member of the Association for at least five (5) years immediately prior to the election, have served on at least three (3) different committees of the Association and have served as an elected or appointed Director or Officer of the Association in the last five (5) years.

### **Treasurer:**

The Treasurer must have been a REALTOR® member of the Association for at least five (5) years immediately prior to the election, have served on at least three (3) different committees of the Association and have served as an elected or appointed Director or Budget & Finance committee member at least one (1) year in the last five (5) years.

### **Elected Director:**

An elected Director shall have been a REALTOR® member of the Association for at least three (3) years immediately prior to the election or shall have graduated from Louisiana REALTORS® or RAA's leadership academy and shall have served on at least three (3) different committees of the Association in the last five (5) years.

### **Out-of-Parish Director:**

This seat shall be designated for a member who, according to Association membership records, is affiliated with a brokerage office that operates outside of Lafayette Parish, but within the Association's jurisdiction as established by the National Association of REALTORS®.

### **Louisiana REALTORS® Director:**

As a local board within Louisiana REALTORS® the RAA is allotted a certain number of board seats for the Louisiana REALTORS® board of directors. Seat allocation from Louisiana REALTORS® is based on membership size of the RAA. One (1) seat shall be an elected seat from the RAA membership. Members wishing to run for the elected seat must meet LR's eligibility of service for the board of directors, which is a REALTOR® member who is in good standing for five (5) consecutive years. Anyone wishing to run shall have their name placed on the ballot and run during the RAA's annual election.

## How the Nomination Process works & How the Nomination Committee functions:

The nominating committee shall annually solicit written applications from REALTOR® members interested in serving on the Board of Directors as an Officer or Director. The Nominating Committee shall select no more than two (2) nominees for each officer position. The Nominating Committee shall select no more than two (2) nominees for each director vacancy with no more than two (2) from any one office, excluding officers. The Nominating Committee's report shall be distributed to the membership eligible to vote within 30 days of the annual election. Individuals nominated must have consented to the nomination prior to being placed on ballot. Nominees may only be nominated for one position, officer or director, with the exception of individuals nominated for state or national elected positions.
